## Election Process for the October 27, 2020 Local 201 General Election

This issue of the IUE-CWA Local 201 News is devoted to the upcoming union Officer Elections. It contains a list of Officers, Delegates and Union Health and Safety candidates along with their Readers and photographs. The General Election will be held on October 27, 2020 for all positions. Polling locations will include: GE Lynn bldg. 96 Auditorium, Veolia Water Lynnway Plant, Avis/ Budget Logan Airport, Saugus Public Library, Ametek Aerospace Wilmington, MA. and the IUE CWA Local 201 Union Hall. Voting times and sample ballots will be published in the October issue of this newspaper. Use your membership card, company badge or personal ID to vote. If you have any questions about your status, ask your steward or E Board member or come down to the Local 201 Union Hall at 112 Exchange Street Lynn MA. If you are elected on October 27, 2020 you begin your term in office on October 28, 2020. Absentee ballots will be available. Contact union hall for information at 781-598-2760.


We must stop accepting defeat. In order to prevail we must stand together and with that said, I respectfully ask for your vote.


